

Thoreau Park Elementary School Parental Involvement Policy/Plan



PART I. GENERAL EXPECTATIONS

Thoreau Park agrees to implement the following statutory requirements:

- 6. Thoreau Park Elementary School will provide each parent an individual student report about the performance of their child on the State assessment in at least math and language arts.
- 7. Thoreau Park Elementary School will provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by district letter.
- 8. Thoreau Park Elementary School will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions below
 - > the state's academic content standards
 - > the state's student academic achievement standards
 - > the state and local academic assessments including alternate assessments
 - > the requirements of Part A
 - > how to monitor their child's progress
 - > how to work with educators

- 9. Thoreau Park Elementary School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

 - > Inviting Speakers on Specific Topics (Denver Daniel, Cathy Catalano)
- 10. Thoreau Park Elementary School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- 11. Thoreau Park Elementary School will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
