Whereas, the Focus on the Future Action Teams addressed the following areas: Athletics/Extra Curricular Activities, Community Engagement, Curriculum/Instruction, Facilities/District Operations, Finances, Restoring Trust, and Technology; and

Whereas, members of these Action Teams committed to work together moving the Parma City School District positively into the future consisted of Parma City School District employees, community members and students; and

Whereas the Teams met on four separate occasions to develop short term goals to begin their process and on February 21, 2017 the seven Action Teams presented their short term recommendations to the Board of Education, and

Whereas, the Board of Education held Special Meetings on March 2, 9 and 16 to allow the Board of Education members an opportunity to speak with the Action Teams in an informal dialogue to gather additional insight into their recommendations; and
