21st Century Grant Program / Parma High Discovery Center Parent Information Sheet

September 2020

Dear Parents/Guardians of Parma Senior High School Students:

You can now register your child for the 21st Century Community Learning Center Grant Program, **Parma High Discovery Center**. This federally funded program is a *free* after school program designed to serve the 8th through 12th grade students of Parma High School. The objectives of the Discovery Center emphasize Academic Intervention in Math and Reading, College and Career Exploration, Increase Graduation Rates, Credit Recovery, Youth Development Enrichment Activities, and Parent Engagement. We are an inclusive environment where your child can make friends, let the stress of their day go, and learn to learn through enriching activities with the help of caring teachers and tutors. This is a phenomenal opportunity for your child, one that can open new areas of interests and career exploration for their future.

Two different programs are available at the Discovery Center:

1. **Credit Recovery** is for students who have failed a course and rather than taking that course again, they can recover that credit through our on-line APEX program. Students must first discuss enrolling in the Discovery Center Credit Recovery program with their school counselor. There are assigned Math, English, History, & Science teachers to work with students. All Credit Recovery students must attend Monday – Thursday 2:30 – 5:00. If for some reason your child cannot make all four days, parents and students must meet with the site coordinator to work out an acceptable arrangements. We do make exceptions but they are on a case by case basis. There are limited seats available so we prioritize with seniors first and we will remove students not meeting our attendance requirements.
2. **Homework/Tutoring and Enrichment** is available for students needing a positive encouraging place to do their homework, get tutoring help if they need it and participate in fun, active, and enriching activities. Students begin their day at the Discovery Center enjoying a snack, reviewing their agenda and homework assignments with our available teachers and working in the APEX tutorial program which prepares students for taking the AIR tests in the spring. From 3:00 to 4:00, students work on homework and/or receive tutoring from our teachers. Enrichment activities start at 4:00 and end at 5:00. Enrichment activities may include; Cooking, Yoga and Mindfulness, Team Sports, Swimming, Games/ Chess, Art/Stained Glass/Sculpting, and Music. The Discovery Center operates Monday –Thursday 2:30 – 5:00. Students must attend all four days for the entire time. If for some reason your child cannot make all four days, parents and students must meet with the site coordinator to work out an acceptable arrangements. We do make exceptions but they are on a case by case basis. Space is limited and students not meeting our attendance requirements can be removed.

There are three (3) sessions available. When you register your child into a session, they are expected to attend **from 2:30 – 5:00 pm** on their assigned in-school days for the entire session. You can withdraw your child at the end of a session. Due to student teacher ratios outlined by The State of Ohio, space will be limited. If your child is not meeting attendance requirements they can be removed to allow other interested students to attend. A wait list will be maintained. Once your child is enrolled, we automatically enroll them into the next session unless you contact us to withdraw your child.

Due to the COVID-19 pandemic this year, we are modifying our schedule and programming will be flexible to accommodate district learning schedules. If we are distance learning only, Credit Recovery will be available but not Homework/Tutoring and Enrichment. When students are learning through the hybrid schedule, all students attend the Discovery Center on their assigned in-person days. When school resumes regular in-school days Monday - Friday, the Discovery Center will be open Monday – Thursday and will be closed on Fridays.

There will be administrative planning weeks between sessions. The Discovery Center will be closed between sessions and for Thanksgiving, Winter, & Spring Breaks.

Schedule is based on Virtual learning September 22 – 25th, Hybrid Learning September 28th – December 18th, and full In-School learning after January 1st. Schedule is subject to change depending upon Parma District School policy.

Parents and/or Guardians are responsible for arranging a way home for their child each day. All students are dismissed by 5:00 p.m. Please be timely. If your child will be absent, late, or if you need to pick them up early, please call us at 440-885-8638. **Students cannot leave early without permission from their parent/guardian.**

All parents and families are expected to participate in our Family Event nights. These events will be scheduled once allowable by The State of Ohio and are held after regular Discovery Center hours. Information for these events will be provided to students well in advance of the event. Registration for family events will be required. Field trips will be scheduled once allowable by The State of Ohio. All registered students are expected to attend all field trips as they are part of our programming.

Please review the **Registration Packet** and complete the attached registration forms completely. Your child needs to return the attached forms to the Parma High Discovery Center office located in the Media Center, or to your child’s school counselor and they will forward to us at the Discovery Center.

Discovery Center at Parma Senior High School CODE OF HONOR

RULES:

- **Discovery Center is open 4 days/week 2:30 – 5:00**
- **Student is expected to attend entire time on assigned in-school days.**
- Tell adults in charge before leaving the program to go anywhere.
- It is the student's responsibility to sign in and out every day.
- Parma High School rules and consequences apply. Respect students and staff with your actions and words.
- Respect the property of others, the school and the Discovery Center.
- Personal electronics, such as cell phones can be used with the permission of the site coordinator. If student abuses this privilege, the site coordinator can and will remove the device until student leaves for the day.
- Use appropriate language and voices.

The Discovery Center operates with a **Model of Progressive Discipline:**

1. First Offense/First Warning – Verbal consultation with the student (**exceptions listed below). Child may be removed from remainder of that day's program depending upon the nature of the offense.
2. Second Offense /Second Warning – Verbal consultation with the student (**exceptions listed below). Child may be removed from the remainder of that day's program depending on the nature of the offense. Parent/Guardian is called and the child may be picked up.
3. Third Offense/Third Warning – Verbal consultation with the student. Parent/Guardian is called. Child is removed from the program for the remainder of the week, session or school year, to be determined by program staff depending on the severity of the offense.

The Discipline Code may be altered at the discretion of the Administration.

*****EXCEPTIONS: There is zero tolerance for bullying and acts of physical aggression towards staff and other students.** Acts of bullying or physical aggression will result in suspension or expulsion from the Discovery Center at Parma High School and may also result in school disciplinary action.

Enrichment activities will include music, art, sports, cultural experiences, careers, character development, technology, and social skills. These activities will be administered by community partners and volunteers such as yourself. PARENT / GUARDIAN MEMO OF UNDERSTANDING AND PERMISSION

My child and I understand that he or she must attend from 2:30 – 5:00 on all assigned in-school Discovery Center days. There are allowable exceptions. **Site coordinator** must be aware and sign off on any exceptions. If my child misses 3 unexcused days as scheduled, he/she may be withdrawn from the program.

I understand that I am to attend parent/family nights.

I understand that my child is to attend all field trips

I give my consent to have my child photographed and/or interviewed for the Discovery Center newsletter and/or bulletin board displays.

If my child is enrolled in the Discovery Center Credit Recovery program, my child and I understand that they must attend the Discovery Center on their assigned in-school learning days from 2:30 – 5:00 and have 12 hours per week logged in and working in the APEX on-line program. Hours in APEX are monitored.

- ID's are not checked when students are picked up unless information is provided regarding the name of anyone not permitted to pick up your child.
- Discovery Center program activities may include positive youth development workshops, community service learning projects, sports, challenging physical activities and walking in the community under adult supervision. I understand that a risk of injury exists when students participate in activities, sports and challenging physical activities. Occasionally, the Discovery Center students will leave the school building to walk and play sports on school grounds with adult supervision as a part of activities.
- Discovery Center tutors, staff, program partners, and program evaluators obtain and review certain school records needed to help plan appropriate support services and to provide data required in the program reports to the Federal Government. All records and information about the students will be kept confidential.
- The Discovery Center *Parent Information Sheet* and Discipline Code explains policies and procedures for this program. It is the responsibility of all children and families participating to cooperate with the procedures and provide current and accurate emergency information to the Discovery Center staff.
- I have read the *Discovery Center at Parma High Information Sheet, the Rules* and the *Discipline Code*. I am aware of and understand the policies. I understand that cooperation with policies and procedures is important for all students and families participating in the Discovery Center program. I agree to comply with the policies outlined.
