

## **Renwood Elementary School Parental Involvement Policy/Plan**

### **PART I. GENERAL EXPECTATIONS**

The **Renwood Elementary School** agrees to implement the following statutory requirements:

5. Renwood Elementary School will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
  - E-mail
  - Phone calls
  - Notes home
  - Parent Teacher evening conferences
  
6. Renwood Elementary School will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
  - Letter to parent
  - OAA test scores
  - Conferences
  - Dibels scores 3 times a year showing if student is at benchmark, below or well below

7. Renwood Elementary School will take the following actions to provide each parent timely notice: when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
  - Letter from Human Resources
  
8. Renwood Elementary School will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph –
  - ◆ the state’s academic content standards,
  - ◆ the state’s student academic achievement standards,
  - ◆ the state and local academic assessments including alternate assessments
  - ◆ the requirements of Part A
  - ◆ how to monitor their child’s progress, and
  - ◆ how to work with educators:
    - Principal, Joy Hollo, will share
  
9. Renwood Elementary School will provide materials and training to help parents work with their children to improve their children’s academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
  - Math Speak nights- series of three
  - Packet of literacy information
  - Starfall website
  - Ladders to Success
  - Parenting Partners program
  
10. Renwood Elementary School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
  - Home liaison
  - School handbook
  - Parma collaborative
  - FAST program
  - Parenting Partners program
  
11. Renwood Elementary School will, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for

Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
